1. Who This Policy Applies To

3. Why We Collect Personal Information

We collect and use your information so we can:

- Provide you with services
- Answer your questions or support requests
- Improve your experience on our website and apps
- Send you updates or marketing (only if you want them)
- Meet legal or business obligations

We always make sure we have a valid reason (called a "legal basis") to collect and use your information.

4. What Information We Collect

We may collect:

- Your name, job title, company name
- Your email address or phone number
- What pages you visit on our website
- Device and browser details
- What content you download or forms you fill out
- Information from event signups or ads you've interacted with

Some of this data is collected directly from you, and some is gathered automatically using cookies and tracking tools.

5. How Long We Keep Your Data

We only keep your personal information for as long as we need it. This depends on why we collected it in the first place. After that, we either delete or anonymize it.

6. How We Keep Your Information Safe

We use strong security tools and processes to keep your personal data safe from loss, misuse, or unauthorized access. While no system is 100% secure, we take privacy seriously and are always working to improve.

7. Sharing Your Information

We don't sell your personal information. We may share it with trusted service providers who help us operate our website, deliver services, or run advertising. We also share information if required by law.

If your data is transferred outside your country (like to the U.S.), we use legal safeguards like Standard Contractual Clauses (SCCs) to protect it.

8. Your Rights if You're in the EU

If you're in the European Union, you have the right to:

- See what data we have about you
- Ask us to correct or delete it
- Ask us to stop or limit how we use it
- Take your data with you (data portability)
- Withdraw your consent if you gave it
- File a complaint with a privacy authority

- Ask to see what personal info we've collected
- Request a copy of your information
- Ask us to delete or correct your data
